Classification of the Mixture: Clear colorless liquid. Eucalyptus odor.

Most Important Hazards: Highly flammable liquid and vapor. May cause drowsiness and dizziness.

Precautionary Statements:

Keep away from heat/sparks/open flames/hot surfaces. - No smoking.

Keep container tightly closed.

Ground/bond container and receiving equipment. Use explosion-proof electrical/ ventilating/ lighting/ equipment. Use only non-sparking tools.

Take precautionary measures against static discharge.

Use only outdoors or in a well-ventilated area.

Eyes - Avoid contact with eyes. If in eyes, rinse with water for several minutes. Remove contact lenses, if present and easy to do.

Continue rinsing. If eye irritation persists, get medical attention.

Section 4 First Aid Measures

Eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. If redness, burning, blurred vision or irritation persists, transport to nearest medical facility for additional treatment.

Skin: If irritation occurs, get medical attention. Remove contaminated clothing. Do not reuse clothing until cleaned. If material is injected under the skin, transport to the nearest medical facility for additional treatment. If redness, swelling, pain and/or blisters occur, transport to the nearest medical facility for additional treatment.

Ingestion: Do NOT induce vomiting and obtain medical attention. Have victim rinse mouth out with water. If vomiting occurs spontaneously, keep head below hips to prevent aspiration.

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If the victim has difficulty breathing or tightness of the chest, is dizzy, vomiting or unresponsive, give oxygen with rescue breathing or CPR as required and transport to the nearest medical facility.

If used inappropriately, it can be an irritant to the eye. Product is not designed to be ingested.

Thoroughly wash with fresh water. If irritant persists, please contact immediate medical attention.

Section 5 Fire Fighting Measures

Flammable Properties:

Flash point: 65.1 °F (ASTM D56) Flammable limits in air: 2% Auto ignition temperature: 399°C

Extinguishing media: CO₂, dry chemical alcohol resistant foam

Special firefighting measure:

Flammable. Vapors may form explosive mixtures with air. Vapors are heavier than air and may spread along floors. Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Use foam or dry chemical to extinguish fire. Water may be used only to keep surrounding containers cool. Firefighters should wear proper protective equipment and self-contained breathing apparatus with full face piece operated in positive pressure mode.

Section 6 Accidental Release Measures

- Eliminate ignition sources and ventilate area.
- Absorb spillage with inert absorbent material.
- Contain spill and keep from entering waterways or sewers.
- Advise EPA/state agency if required.
- Use proper personal protective equipment for clean-up.
- Treat contaminated absorbent same as spilled product.

Section 7 Handling and Storage

Handling and Storage Precautions: Avoid heat, open flames, including pilot lights, and strong oxidizing agents. Use general ventilation to prevent vapor accumulation. Ground all handling equipment to prevent sparking. Avoid prolonged contact with eyes, skin and clothing. Do not eat, drink or smoke when using this product. Have appropriate fire extinguishers and spill clean-up equipment in or near storage area.

Work/Hygienic Practices: Wash with soap and water before eating, drinking, smoking, applying cosmetics, or using toilet. Launder contaminated clothing before reuse. Properly dispose of contaminated leather articles such as shoes or belts that cannot be decontaminated. Contaminated leather articles including shoes cannot be decontaminated and should be destroyed to prevent reuse.

Section 8 Personal Protection/ Exposure Controls

Engineering Controls: Use adequate ventilation to keep vapors and mists of this material below applicable standards.

Respiratory Protection: If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker health, an approved respirator must be worn.
